## Regulations:

1. **The nomination form must be signed** by two (2) CUFA members and by the nominee. All signatories must be members in good standing, i.e., must have a current, valid CUFA membership form on file at the CUFA Office. If any of these criteria are not met, the nomination will be deemed invalid. The nomination period is from March 3, 2025 until 4:00 pm on Friday, March 21, 2025.
2. **Statement.** Candidates must provide a **brief statement not exceeding 200 words** to be published on the CUFA website starting on March 24, 2025. This statement will also be included on the ballot. It should outline the **nominee’s qualifications** for serving on the CUFA Executive and why you should be elected. Optionally, you may include a photo and/or a link to your personal or university web page. Elections will begin on March 31, 2025 and will end on April 4, 2025.
3. **Submission.** Duly signed nomination forms and statements must reach the CUFA Office, **by 4:00 P.M. on Friday, March 21, 2025.** Nominations may be sent by e-mail to Chantal Bohbot ([c.bohbot@concordia.ca](mailto:c.bohbot@concordia.ca)).
